Application Rates and Guidelines

Use a minimum of 1 U.S. gallon per 1,000 sq. ft. (3.8 liters of water per 93 sq.meters). Fill spray tank with half of required spray water and turn on agitation. Measure product, put into the tank and add remaining water and other desired soluble products. Add a de-foaming agent and adjust pH of tank-mix, if necessary. For best results, apply in the early morning or late afternoon.

Emerald Isle liquids are concentrated materials and are compatible with most fertilizers and chemicals, but should not be mixed directly with other chemicals. They should be mixed in spray tanks with water and proper agitation. Conduct a jar test, as needed, to ensure compatibility with other products before tank mixing.

| Use as a Spreader | Apply 8 oz. for every 100 gallons of spray mix (236.6 ml for every 378.5 L of spray mix) |

AGITATE BEFORE USE

Storage and Use Guidelines

Store in the original containers at temperatures between 50° F and 90° F (10° C and 35° C). Mix with other materials only at the time of application and in exact amounts required. To avoid contamination, do not return previously mixed product to its original container. Use all product within 12 months of original purchase date.
