APPLICATION TO TURFGRASS

The use of this product will provide plant nutrients as well as providing control of selected insect pests. Lebanon Proscape Fertilizer with Merit 0.3% Insecticide can be used for the control of soil inhabiting pests of turfgrass; for example northern & southern masked chafers, *Cyclocephala borealis*, *C. immaculata*, and/or *C. lurida*; Asiatic garden beetle, *Maladera castanea*; European chafer, *Rhizotrogus majalis*; Green June beetle, *Cotinus nitida*; May or June beetles, *Phyllophaga* spp.; Japanese beetle, *Popillia japonica*; Oriental beetle, *Anomala orientalis*, billbugs, *Sphenophorus* spp.; annual bluegrass weevil, *Listronotus maculicollis*; Black turfgrass ataenius, *Ataenius spretulus*; *Aphodius* spp.; crane flies, *Tipula* spp., and mole crickets, *Scapteriscus* spp. This product can be used as directed on turfgrass; for example, in home lawns, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, and athletic fields. This product cannot be used on commercial sod farms.

The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Do not apply when turfgrass areas are waterlogged or the soil is saturated with water. Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated turf must be in such a condition that the rainfall or irrigation will penetrate vertically into the soil profile. Applications cannot exceed a total of 133 lb (0.4 lb of active ingredient) per acre per year.

APPLICATION TO ORNAMENTALS

This product can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. This is a systemic product, with the active ingredient being absorbed by the roots and translocated upward within the plant. Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation or rainfall to place the active ingredient into the soil. Make application prior to anticipated pest infestation to achieve optimum levels of control.

Applications of this product cannot exceed a total of 133 lb (0.4 lb of active ingredient) per acre per year.
