AGRIplex® is formulated for soil or foliar application and is designed to supplement all fertilizer programs. It is an excellent tank mix buffer. AGRIplex® can be applied through injection and drip irrigation, fertigation, or sprayer system. Low moisture conditions may limit nutrient uptake, so a minimum dilution of 1:30 in water is recommended. Maximum dilution should not exceed 1:600.

Compatibility: AGRIplex® is tank mix compatible with most soluble fertilizers, herbicides, fungicides and absorbent gels. As with all chemicals, read all labels for compatibility verification and, if practical, test on a small area prior to extensive use with other chemicals. If in doubt, call 800-233-1067 with questions.

DO NOT APPLY WITH ALUMINUM BASED FUNGICIDES.

STORAGE
