Application Rates:

To feed at the rate of 0.9 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 3.6 lbs per 1,000 sq. ft. or 156 lbs. per acre. To feed at the rate of 0.5 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 2 lbs per 1,000 sq. ft. or 87 lbs. per acre.
