Do not apply Lebanon ProScape fertilizer with Merit® Grub Preventer in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirement specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS	
Use Lebanon ProScape fertilizer with Merit® Grub Preventer only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. APPLICATION TO TURFGRASS

The use of Lebanon ProScape fertilizer with Merit® Grub Preventer will provide plant nutrients as well as providing control of selected insect pests. Lebanon ProScape fertilizer with Merit® Grub Preventer can be used for the control of soil inhabiting pests of turfgrass, for example northern & southern masked chafers, *Cycocephala borealis*, *C. immaculata*, and/or *C. lurida*; Asiatic garden beetle, *Maladera castanea*; European chafer, *Rhizotrogus majalis*; Green June beetle, *Cotinus nitida*; May or June beetles, *Phyllophaga spp.*; Japanese beetle, *Popillia japonica*; Oriental beetle, *Anomala orientalis*; *Euethoela humilis rugiceps*; sugarcane beetle, *Euethoela humilis rugiceps*, billbugs, *Sphenophorus* spp, annual bluegrass weevil, *Listronotus maculicollis*. Black turfgrass ateniens, *Ataenius spretulus*; *Aphodius* spp.; crane flies, *Tipula* spp., and mole crickets, *Scapteriscus* spp. Use Lebanon ProScape fertilizer with Merit® Grub Preventer as directed on turfgrass including home lawns, school grounds, nursing homes and hospital grounds, city, county, state, municipal and federal grounds, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, churches, cemeteries, parks, playgrounds, athletic fields and sod farms.

The active ingredient in Lebanon ProScape fertilizer with Merit® Grub Preventer has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated turf must be in such a condition that the rainfall or irrigation will penetrate vertically into the soil profile.

APPLICATION TO ORNAMENTALS

Lebanon ProScape fertilizer with Merit® Grub Preventer can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. This is a systemic product, with the active ingredient being absorbed by the roots and translocated upward within the plant. Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation or rainfall to place the active ingredient into the soil. Make application prior to anticipated pest infestation to achieve optimum levels of control.

Applications of Lebanon ProScape fertilizer with Merit® Grub Preventer cannot exceed a total of 200 lb (0.4 lb of active ingredient) per acre per year.

RESTRICTION: Not for use in commercial greenhouses, or nurseries.

APPLICATION EQUIPMENT

Apply Lebanon ProScape fertilizer with Merit® Grub Preventer uniformly over the area being treated with typical granular application equipment. Both drop-type and rotary-type spreaders may be used to apply Lebanon ProScape fertilizer with Merit® Grub Preventer. Avoid the use of spreaders which would apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately.

USE RESTRICTIONS

- Do not apply more than 200 lb (0.4 lb of active ingredient) per acre per year.

- For optimum control, irrigate if rainfall does not occur within 24 hours after application to move the active ingredient through the thatch.
- On golf courses, irrigate treated areas following application.
- For optimum control, mow turf or lawn area only after irrigation or rainfall has occurred so that uniformity of application will not be affected.
- Avoid runoff or puddling of irrigation water following application.
