Application Rates

To feed at the rate of 0.9 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 4 lbs per 1,000 sq. ft. or 175 lbs. per acre.

To feed at the rate of 0.5 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 2 lbs per 1,000 sq. ft. or 88 lbs. per acre.
