4. FIRST AID MEASURES

Eye Contact	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
Skin Contact	Wash with soap and water. If injury occurs, or if discomfort or irritation persists contact a physician.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

6. ACCIDENTAL RELEASE MEASURES

If in eyes, rinse cautiously with water for several minutes. If eye irritation persists: Seek medical advice. If experiencing significant respiratory symptoms: seek medical attention.
